Nursery Admissions Policy

Bishop King School is an inclusive church school. We welcome children from all backgrounds and abilities.

Bishop King Nursery offers places for 38 weeks during the academic year in line with the school's term dates. We have three intakes over the school year in September, January and after Easter, where we offer morning, afternoon or 30-hour places for all children from the term after their 3rd birthday.

- Born between 1 April-31 August: eligible from the start of term beginning on, or following 1 September after the child's third birthday.
- Born between 1 September-31 December: eligible from the start of term beginning on or following 1 January after the child's third birthday.
- Born between 1 January-31 March: eligible from the start of term beginning on, or following, 1 April after the child's third birthday.

Funded 15-hour places

Nursery children are offered three hour sessions daily:

- 26 nursery children in the morning sessions; 8:40am -11:40am, and,
- 26 nursery children in the afternoon sessions; 12:20pm - 3:20pm

Funded 30-hour places

Funding for full-time children can be obtained through the 30 hours funding scheme.

- Nursery children are offered a full-time place; 8:40am to 3:20pm

A packed lunch from home, or, the purchase of a school meal will be required for all full day sessions. School meals can be purchased through WisePay via the school's website; www.bishopking.org.uk

Application Process

Parents may register their interest in a place at the nursery any time following their child's birth, by contacting the school office. The date on which a child was added to the waiting list will **not** be taken into consideration when places are offered.

The child's birth certificate will be required as proof of their date of birth.

Offering Places

Places for the September entry will be offered during the preceding Summer term to children who will be aged three years by 31st August of that year.

Where places are available for entry in the Spring or Summer terms, these will be offered to children on the waiting list who have reached the eligible age, according to the admissions criteria below.

- Applications must be made by the last school day of Term 5 to be considered to start in Term 1 - this does not include staff training days
- Applications must be made by the last school day of Term 1 to be considered to start in Term 3 - this does not include staff training days
- Applications must be made by the last school day of Term 3 to be considered to start in Term 5 - this does not include staff training days

If there are more children on the waiting list than places available, priority will be given in line with the Oversubscription Criteria below.

Places will be offered by contacting parents by e-mail, letter or telephone using the contact details provided. If no response is received within one week of making the offer, the place may be offered to another child on the waiting list.

Oversubscription Criteria for Three and Four Year Olds:

In accordance with legislation the allocation of places for children with the following will take place first; Statement of Special Educational Needs (Education Act 1996) or Education, Health and Care Plan (Children and Families Act 2014) where the school is named. Bishop King CE Primary School will then allocate remaining places in accordance with this policy:

1. Looked after children and all previously looked after children, including those children who appear to have been in state care outside of England and ceased to be in state care as a result of being adopted. Previously looked after children are children who were looked after but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order).
2. Children living in the ecclesiastical parishes of St Botolph's and St Peter at Gowt's with St. Andrew. See a list of streets in appendix 1.
3. Children with a brother or sister already in the school and who will still be attending at the time the place is required.
4. Children whose parents can provide clear evidence of a religious affiliation which will be verified by a signed letter from an officiating minister at the place of worship. This will be assessed using the following criteria:
 - Parents are faithful and regular worshippers at a Christian Church.
 - Parents are practising members of another faith and wish their children to attend a Christian school because of its religious emphasis and ethos.
 - The child is transferring from a church school and parents wish to maintain the continuity of a church school.
5. Distance of the child's home to the school, with those living nearer being accorded the higher priority, which will be decided by Straight line distance as calculated electronically to three figures after the decimal point (eg 1.543 miles) by Lincolnshire County Council school admissions team from the Post Office Address Point of the home to the Post Office Address Point of the school.

If two or more children are tied for the last place, a lottery will be drawn by an independent person, not employed by the school or working in Children's Service Directorate at the local authority.

Withdrawing offers

Once an offer, either written or verbal has been made, there are limited circumstances in which an offer can be withdrawn – these are as follows:

- Offers made on the basis of fraudulent applications
- Offers made on the basis of intentionally misleading applications
- Parents not responding to an offer within one week

Refusal of admission

A child is only refused admission if one of the following criteria are met:

- The nursery has reached its admissions limit
- The child is not of the appropriate age

Parents do not have a statutory right to appeal against the admission authority's refusal to award a place to their child.

Parents may appeal to the SEND tribunal against the provision named by the authority in the EHC plan.

Admission to Reception

Children who attend the Nursery do not have an automatic place in the Reception classes at Bishop King CE Primary School, and should apply through Lincolnshire schools central admissions.

Transition Arrangements

Before starting nursery, children will be invited with their parents/carers to school to meet our nursery team. During this visit, parents/ carers will have the opportunity to discuss their child's development.

Following the visit, a date will be set for the child to start at our nursery. Each child will have a staggered start to entry, prior to attending their allocated session times, as part of our transition process.
